The main conclusions of the meeting are:

- I. Harmonization of joint contingency plans for the cross-border area.

Developing of a new Annex to Joint Intervention Plan RO-BG for CBRN action – common procedure for intervention in case of CBRN events.

Reviewing and updating of the coordination mechanism between RO and BG national operational centers.

Common training of rescue teams for acting in CBRN accidents – training curriculum – new article in Joint intervention plan and will be organized other 2 more meetings for this purpose

- II. Preparatory measures for conducting common exercise for CBRN emergency situations – end of March / beginning of April 2015.

Place of the Exercise – Giurgiu, Romania.

Scenarios for performing common exercise: Accident in chemical plant and Road accident involving radioactive sources and chemical substances,

Participants: up to 150 participants.

Bulgarian intervention teams from DGFSCP: 1 CBRN reconnaissance team, 1 decontamination team and 1 logistic support team, Team leader and Liaison officer.

- III. The common platform for exchange of CBRN data – DIEX. During the meeting was presented the stage of development for the Web Platform (DIEX) as prepared by the LP-IFIN-HH Romania. There were presented the components of the Platform, the data flow from the equipment to the monitoring and decision making staff.
